#### Jennett's Park CofE Primary School Separated Parents Policy

Our Rainbow Promise underpins everything we do at school. Just as the Rainbow was a sign of God's promise to Noah, that from that moment God would enable Noah and the people of the earth to flourish and experience life in all its fullness, we promise to do our best to enable all the pupils and adults of our school to flourish academically and professionally so that they might reach their potential.

The Rainbow is also a symbol of the diversity of our school community, as a church school, we recognise that we are all created and valued by God, and so, as a school community, we commit to care for and value each other.

### Introduction

Jennett's Park CofE Primary School is committed to supporting the needs of all pupils, including those whose parents are separated. This policy outlines how the school will work with separated parents to ensure all parties are informed and involved in their child's education.

#### Definition of a Parent

For the purposes of this policy, a 'parent' includes:

- All biological parents
- Any person with parental responsibility (e.g., adoptive parents, step-parents, guardians)
- Any person who has care of a child or young person

## Parental Rights and Responsibilities

All parents with parental responsibility are entitled to:

- Receive information about their child's education
- Request to see their child's educational record
- Participate in statutory activities
- Be informed about meetings involving their child
- Be asked to give consent for activities or sharing of information

## Communication with Separated Parents

1. **Contact Details**: The school will maintain up-to-date contact details for all parents with parental responsibility. It is the responsibility of parents to inform the school of any changes.

## 2. Information Sharing:

- Both resident and non-resident parents have the right to receive information about their child's education.
- o The school will provide statutory educational information directly to both parents if requested.

## 3. Meetings and Events:

- The school will invite both parents to attend key meetings and events, such as parents' evenings.
- o Parents should inform the school if they require separate appointments.

## Consent for Activities

- The school will seek consent from the resident parent for school trips and activities unless otherwise requested by the non-resident parent.
- If parents disagree on giving consent, the school will treat it as if consent has not been given.

### Conflict Resolution

- The school will not mediate disputes between parents. Parents are encouraged to resolve conflicts independently, possibly with the help of mediation services.
- The school will follow legal guidelines and court orders if applicable.

### Changing a Child's Name or School

- The school requires written consent from all parties with parental responsibility to change a child's name in school records.
- If a decision is made to move a child to another school, the school will check that all parties are informed and in agreement.

## Safeguarding Considerations

The welfare of the child is the school's primary concern. The school will take into account any safeguarding concerns and follow appropriate procedures.

### Policy Review

This policy will be reviewed every three years or sooner if required by changes in legislation or guidance.
